To be clear, this is all in the very beginning stages and we don't know if our efforts will be successful. I just wanted to let our members know that the ASTEE Board of Directors is fully committed to moving forward with this endeavor. We will keep you all updated as things progress.



Awards Committee

2025 Edmond Locard Award for Excellence in Trace Evidence

The Edmond Locard Award for Excellence in Trace Evidence was awarded to Dr. Tatiana Trejos, Associate Professor of the Department of Forensic and Investigative Sciences at West Virginia University. The nomination letter highlighted Dr. Trejos' contributions to the field of Trace Evidence, just some of which is presented here:

A review of Dr. Trejos' CV reads like a public service announcement for the preservation and improvement of trace evidence analysis as a discipline in forensic science. Dr. Trejos has devoted her career and research efforts to developing ways to improve the collection, preservation, analysis, data



Dr. Trejos is a frequent recipient of NIJ grants for the investigative of improving trace evidence research and interpretation and brings both an academic and practical perspective to her work with ASTM and OSAC in overseeing the drafting and editing of glass analysis standards. She has further contributed heavily to the OSAC Materials Trace Subcommittee with her research in physical fit analysis and has been an active member of the Physical Fit Task Group since its inception. She was also a co-developer of an interlaboratory exercise for forensic paint interpretation and has taken the knowledge gained from that work and used it to develop a similar exercise for forensic glass interpretation. From this work, her participation on the Interpretation Task Group for Trace Materials has also been thoughtful and of tremendous benefit to the work product and the community at large because it has informed her research and ancillary projects such as co-chair of the Trace Evidence Symposium that she has organized as a free educational opportunity to promote trace evidence presentations and research for the past several years.

Dr. Trejos continues to be an active collaborator in interlaboratory exercise efforts that are also more analytical in design in order to use the accumulated data to continue to improve ASTM standards and data analysis and interpretation. Her activity and advocacy in the area of trace evidence analysis is tireless and vital to the sustainability of trace evidence in forensic laboratories and the courts. She is highly deserving of The Edmond Locard Award for Excellence in Trace Evidence and recognizing her place in the lexicon of trace evidence pioneers can only continue to benefit its existence and improvement.

Other Awards that are being offered soon:

Professional Development Award: The ASTEE Professional Development Award supports trace evidence training by providing funding for a McCrone Research Institute class and up to a \$500 travel stipend. Virtual training courses qualify for this award but will not include the \$500 travel stipend. The award is valid for the current year through September of the following year. Professional development activities not only deepen our knowledge and skills as professionals, they also energize us with a new enthusiasm.

Elections Committee

It's that time of year again when we are looking for new members to join the 2026 Board of Directors. If you have been looking for a way to become more involved with the forensic community, serving on the ASTEE Board of Directors is a great way and I encourage you to think about running! We will have 3 positions open for voting as follows:

- President-Elect (1-year term, then serves as President for 1 year): Fulfills the President's duties should the president be absent, leave office or become incapacitated. Serves as a member of the Audit Committee. The President's duties include: presiding at Society and Board meetings; conducting the business of the Society, and promoting the fulfillment of the Society's objectives; designating committee chair members unless predetermined by the Bylaws; approving expenditures between \$100 \$400; and serves as a member of the Elections Committee for two (2) years following service as the President.
- <u>Secretary (2-year term):</u> Records the minutes of the Board and Society business meetings, maintains the Society records, records members' attendance at all business meetings, and files (or appoints an agent to file) any and all necessary documents with New Jersey. In the absence of the Secretary from a business meeting, the presiding officer shall appoint a temporary Secretary to record the minutes of the meeting.
- <u>Director (3-year term):</u> Act at the direction of the executive board (President, President- Elect, Treasurer, and Secretary) to carry out assigned tasks on behalf of the Society. Directors are voting members of the Board.

If you are interested in serving on the ASTEE Board of Directors in any of these positions or even if you are on the fence but have questions, please reach out to Lindsey Admire, ladmire@ncdoj.gov, by **September 2, 2025**. The election will take place via electronic ballot in October.

OSAC Update

The OSAC Registry now contains 235 standards, 250 SDO-published standards and 270 SDO proposed standards, representing over 20 forensic science disciplines. For more information see the Trace Materials subcommittee page on the OSAC website Trace Materials Subcommittee. Additionally, you can visit the Forensic Science Standards Library for a complete list of Registry Archived and forensic science standards. Access to



these standards is free, but now requires registration with ASTM for a compass account. This is also free and easy to do via the <u>NIST access to ASTM page</u>, click on the green "ASTM Standards Access" button. This will launch the ASTM portal, then click register on this page to enter your details for an ASTM compass account. "NISTOSAC" should automatically add as the organization with this link, then add your organization as the additional one and complete your details.
